

ICAEW CHARTERED ACCOUNTANT QUALIFICATION - THE ACA

The ICAEW Chartered Accountant qualification, the ACA, is one of the most advanced learning and professional development programmes available. It is valued around the world in business, practice and the public sector.

To achieve ICAEW Chartered Accountant status, students must successfully complete the ACA qualification, which involves a minimum of three years of practical work experience alongside passing a series of rigorous exams at the certificate, professional, and advanced levels.

Students who have completed or are pursuing a BCom in Accounting and Finance at Curtin Mauritius benefit from significant exemptions. They are exempted from all ACA Certificate level exams and two Professional level exams: Business Strategy and Technology and Financial Management.

Curtin Mauritius currently provides tuition for four Professional level subjects, preparing students for the remaining exams: Tax Compliance, Financial Accounting and Reporting, Audit and Assurance, and Business Planning.
