During the two-year part-time programme, you will be exposed to a well-balanced, blended learning programme during which you will attend interactive lectures, tutorials and workshops.

- The MIB is structured for applicants with ANY degree and industry experience (2 years working in an assistant or deputy manager and above position)
- A Graduate Certificate in Business Fundamentals is recommended for students without the relevant work experience, which will serve as a pathway into the MIB

Duration

The programme is run over 2 years part time (four semesters)

February and July

Application procedures

Candidates must complete the application form available at Curtin Mauritius Future Student Centre and must submit relevant copies of the following documents:

- Copies of educational qualifications
- Copy of Degree and Academic Transcript
- Copy of CV and reference letter from employer
- Reference letters from your current and / or previous employers
- Two passport - size photographs
- Copy of National Identity Card and Birth Certificate
