The ICAEW Chartered Accountant qualification, the ACA, is one of the most advanced learning and professional development programmes available. It is valued around the world in business, practice and the public sector.

To ensure ICAEW Chartered Accountants are prepared for the future, the Next-Generation ACA (starting September 2025) features a revamped curriculum which goes further than ever in embedding three essential competencies at each level of the syllabus: Sustainability, Technology and Ethics.

To achieve ICAEW Chartered Accountant status, students must successfully complete the ACA qualification, which involves a minimum of three years of practical work experience alongside passing a series of rigorous exams at the

certificate, professional, and advanced levels. Students who have completed or are pursuing a BCom in Accounting and Finance at Curtin Mauritius benefit from significant exemptions.

They are exempted from Five ACA Certificate level exams and two Professional level exams. Curtin Mauritius currently provides tuition for four Professional level subjects, preparing students for the remaining Professional exams.

This programme is exclusively available to current students and alumni of the Curtin Mauritius BCom Accounting and Finance programme.
