### **What is the PwC Flying Start Programme?**

This is a unique PwC programme adapted for Mauritius with PwC Mauritius, Curtin Mauritius and ICAEW (Institute of Chartered Accountants in England and Wales). The programme combines academic study, integrated professional work placements and progress towards the prestigious ICAEW Chartered Accountancy qualification, the ACA.

Once you have completed the Curtin University degree, you will be left with only 3 exams and you could be one year away from completing the full ACA qualification.

### **How long does the programme last?**

- > This is a four year programme during which you will fast track your career in Accounting and Finance.
- > Placements, studies and holidays all form part of the curriculum.
- > The Flying Start Programme is structured according to Curtin University BCom Accounting and Finance requirements and will be aligned with the internship placements at PwC. The full study plan will be communicated to FSP students when they join.

### **Can you give me more details about the work placements?**

- > The programme includes progressive work placements with PwC Mauritius (or in the PwC network) for over 56 weeks or more, spread throughout the 4-year period of study.



### **How is this Curtin BCom Accounting and Finance degree different from accounting degrees offered by most other universities?**

- > Most universities offer a single major in Accounting. This degree is a double major in Accounting and Finance.
- > In addition to Accounting and Finance, the degree also provides an orientation towards business and management.
- > ICAEW offers Next Generation ACA unit exemptions (5 certificate level and 2 professional level papers) to holders of the BCom Accounting and Finance degree.
- > Students benefit from work-integrated learning opportunities throughout the degree including projects, work placements and industry guest speakers.

### **Will the work placement be paid?**

- > PwC will offer an attractive placement fee for all periods of placement that will be commensurate with the progress in your academic studies and the work experience you would have gained.

### **Am I guaranteed a job with PwC at the end of the degree programme?**

- > You have a unique opportunity to impress PwC during your placements and demonstrate your confidence and skills to secure a full-time position.

### **What are the ACA papers that I will need to complete and what support will be provided?**

- > Students graduating with the Curtin BCom Accounting and Finance course are exempted for 5 out of 6 certificate level and 2 professional level Next Generation ACA modules. Four remaining professional level ACA modules will need to be completed during Years 2, 3 and 4 of the programme namely: Fundamental Case Study, Assurance, Risk and Reporting, Corporate Reporting, Data and Assurance, Tax Compliance and Planning.

Curtin Mauritius will provide learning support sessions to prepare the students for each of the four professional level Next Generation ACA modules.

Upon successful completion of the FSP, students will left with one certificate level module (Sustainability and Ethics) and 2 Advanced level modules (Technical Case Study and Strategic Case Study) to complete.



### **Will I be a qualified accountant by the time I have completed the degree?**

- > Upon successful completion of the PwC Flying Start Programme i.e 4 years, you will be left with one certificate level exam and two Advanced Level exams.
- > Your placements at PwC will contribute towards approximately half of the relevant work experience with an ICAEW authorised training employer, required to become an ICAEW Chartered Accountant

### **What are the fees for this degree programme?**

- (I) Curtin University BCom Accounting and Finance fees - Approximately 900,600
- (II) Additional payment for ICAEW Annual Student Fee, ACA learning materials, tuition fee for ACA modules and ACA exams - Approximately 205,791 [based on current exchange rate and fees charged by ICAEW] \*
- (III) You should be able to recover part of these additional payments through your 56 weeks or more of placement with PwC

### **Does the programme offer scholarships?**

The FSP is a self-funded programme and there is, for the moment, no scholarship associated with the programme. However, FSP students will get the opportunity to be remunerated during their work placement at PwC.

### **How many attempts are permitted when taking ACA exams ?**

ICAEW regulations allow a maximum of four attempts at each Professional Level exam. As part of the FSP, you will be expected to successfully pass four professional level exam within the time frame of the programme. In the event that you fail an exam, you will be required to take it again before the next exam is due. Once you have commenced your second work-placement, you will enter into a formal ACA Training Agreement with PwC. You will have to pass the exams in accordance with this agreement.

### **What type of candidate is likely to be successful in securing an offer on the PwC Flying Start Programme?**

- > This is an academically demanding programme. Progression requirements for each year will be higher than for our other degree programmes
- > We will need evidence of your academic ability to meet entry requirements. Your career motivation and evidence of potential professional skills and competencies are equally important
- > There will be 3 stages in the selection process:
  - Stage 1: Meeting Curtin Mauritius entry criteria based on predictive results
  - 2: Interview with PwC / Curtin Mauritius
  - 3: Aptitude test

Prior to your individual interview, you will receive a link to a PwC-approved aptitude test. The purpose of this test is to help us better understand your problem-solving ability, time management skills, agility, and ability to work under pressure.

Your place on the FSP will be confirmed subject to final confirmation of HSC results meeting the entry requirements.
